ARTICLES OF ORGANIZATION
OF
A DPER DESIGN, LLC

1. Name. The name of this limited liability company is **A Dper Design, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist effective as of April 7, 2008 and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 1503 W. River Lane, Tampa, Florida 33603.


