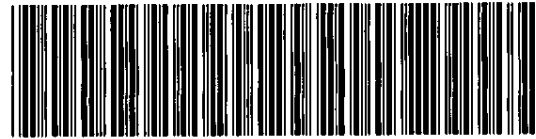


ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION OF  
ALLIANCE STRATEGIES, LLC

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **ALLIANCE STRATEGIES, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, *Florida Statutes* § 608.411:

1. Name of Company. The name of the Company is **ALLIANCE STRATEGIES, LLC**.
2. Date of Filing of Articles of Organization. The Company filed its Articles of Organization with the Florida Department of State effective on April 11, 2008 (the "Articles").
3. Amendments to Articles of Organization. Paragraph 4 of the Company's Articles is amended by deleting the current text thereof in its entirety and substituting the following in lieu thereof:
