

**ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

ARTICLE 1 – Name: Diversified Stock Reports, LLC

ARTICLE 2 – Address: The mailing address and street address of the principal office of the Company is 4940 N.E. 27th Avenue, Lighthouse Point, Florida 33064.

ARTICLE 3 – Registered Agent: The name of the initial registered agent of the Company is William Pirkle. The initial street address of the registered office is 4940 N.E. 27th Avenue, Lighthouse Point, Florida 33064.


