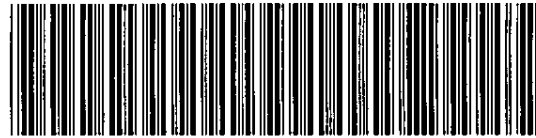

The name of the Limited Liability Company is "**RUSSELL FAMILY PROPERTIES II, LLC**" (the "**Company**").


