ARTICLES OF ORGANIZATION

Article I. Name

Article IV. Transferability of Membership Interests

The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss deduction, credit or similar item to which the assigner was entitled, to the extent assigned.
