ARTICLES OF ORGANIZATION OF TRANSAMERICAN EXPORTS, L.L.C.

ARTICLE I - Name

The name of this Company is TRANSAMERICAN EXPORTS, LLC.

ARTICLE II - Purpose

This Company is organized for the purpose of the export of motor vehicles and motor vehicle parts and transacting any and all lawful business for which limited liability companies may be formed under Chapter 608 of the Florida Statutes.
