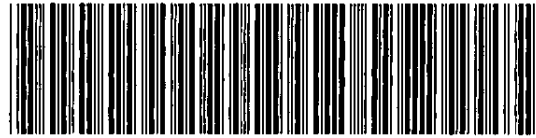




**ARTICLE VI**

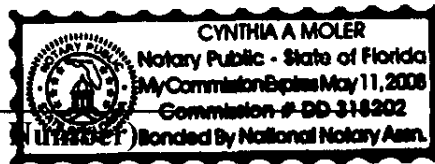
