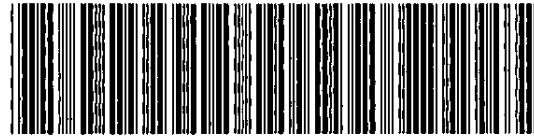

2. Except as modified by this Certificate of Amendment, the Articles of Organization and all other terms and conditions shall remain in full force and effect.

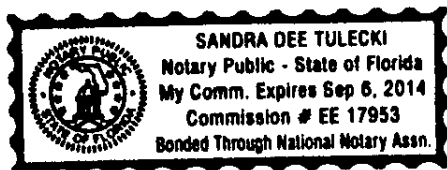


