

ARTICLES OF ORGANIZATION

OF

SALADINO BASEBALL ACADEMY AND SPORTS TRAINING, LLC

The undersigned authorized representative hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I Name

The name of this limited liability company (the "Company") shall be:

SALADINO BASEBALL ACADEMY AND SPORTS TRAINING, LLC

ARTICLE II Principal Office and Mailing Address

776 W. Lumsden Road, Suite 106 Brandon, Florida 33511

ARTICLE III Registered Office and Registered Agent

The initial registered office of the Company shall be located at 120 South Willow Avenue, Tampa, Florida, 33606, and the initial registered agent of the Company at such office shall be James R. Schaffer. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE IV Operating Agreement

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be vested in the members of the Company. The Operating Agreement of the Company shall be for the government of the Company and may contain any provisions or requirements for the management or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles or contrary to the laws of the State of Florida or of the United States.

ARTICLE V Management of the Company

The management of the Company shall be vested in its members. Accordingly, the Company shall be a member-managed company.

ARTICLE VI Amendment of Articles of Organization

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
