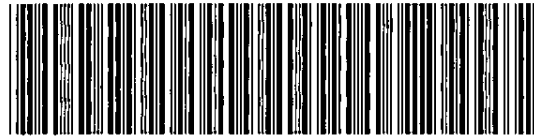

4. Place of Principal Office. The mailing and street address of the Company's principal office is 831 Brightwaters Blvd. NE, St. Petersburg, Florida 33704.

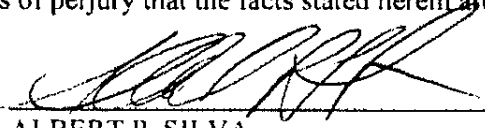

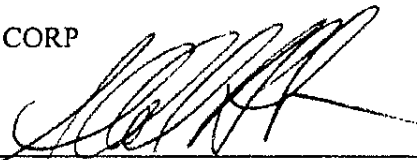
