FIRST: The name and address of this Company is **BAY ST LOUIS PROPERTY MANAGEMENT LLC**, 14243 Northwest 22nd Street, Pembroke Pines, Florida 33028.

SECOND: The date of the adoption of these Articles of Dissolution is 15 June 2012.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members.
