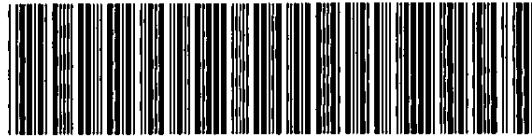

3. Principal office and Mailing address: 4420 NE 26th Avenue, Lighthouse Point, FL 33064.

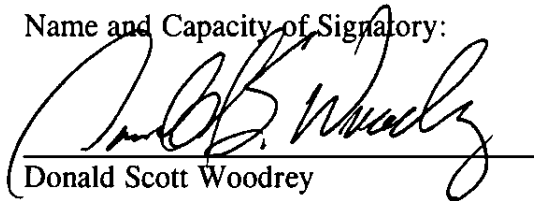
