**ARTICLE II - PRINCIPAL OFFICE**


The mailing address and street address of the principal office of the Company is 140 South Atlantic Avenue, Suite 300, Ormond Beach, Florida 32176.

The Company will be managed by one or more managers and, therefore, it is a manager-managed Florida limited liability company.




