

ARTICLES OF ORGANIZATION OF
(RMBM Construction LLC), A LIMITED LIABILITY COMPANY

KNOW ALL MEN BY THESE PRESENTS; That We,
RUSSELL McINTYRE, BILLY MULCAIRE desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida limited liability act, do establish:

1. **Company Name:** That the name of the limited liability company is RMBM Construction LLC Limited Liability Company.
2. **Duration:** That the duration of this limited liability company is thirty years from the date of filing hereof with the Florida Department of Secretary of State, or unless sooner dissolved as provided by Florida law.
3. **Purpose:** That the purpose for which this limited liability company is organized is primarily for the purpose of commercial and residential construction and repair or installation of commercial and residential components, goods and services that are permitted by law, within and without the State of Florida as the laws of Florida and other states permit.


