Requirements to establish branches of duly incorporated foreign business entities

1 The corporation's Certificate of Goodstanding issued by the local Public Registry, with the notation that nor the Social Agreement or its By-laws prevent to establish branches overseas.

- Copy of the Social Agreement, By-laws, Articles of Incorporation or any other document granted for the incorporation process of your company in Florida.
- Resolution adopted by the Shareholder's Meeting, Board of Directors or any other competent ontity of the company, expressly deciding over the matters set forth:
 - To establish a branch with domicile in Lima, Peru.
 - Name of the branch.
 - Assigned capital of the branch. There is no minimum required. Notwithstanding, \$<u>2500</u> equivalent to S/. <u>7500</u> is advisable as minimum, in order to be able to open a local bank account.
 - Purpose of the branch. Activities of the branch should fall within the scope of activities allowed for the company in Florida.
 - Appointment of at least one legal permanent representative in Peru, with sufficient authority to act on behalf of the branch in Peru. Specific Power of Attorney required.
 - Agreement to submit to any applicable Peruvian regulations and legislation, in order to guarantee compliance with all the mandatory obligations currently in force in Peru.

I will draft this competent entity resolution in Spanish and will send it so you, so it can be include it in the Minute Book of your company. It is more convenient that this resolution is drafted in Spanish, in order to save time and avoid translation expenses.

These documents should be legalized by a competent Public Notary in Florida and thereafter by the local Peruvian Consul (probably the Consul in Miami). Upon receipt of the documents in Lima, legalization before the Ministry of Foreign Affairs will be required and finally, official translation into Spanish of the documents.
