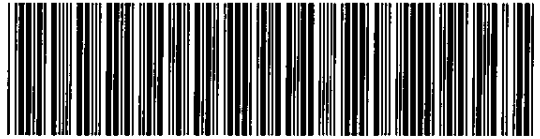

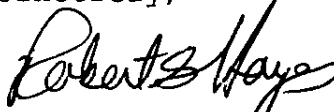

ARTICLE I. COMPANY NAME

The name of this Limited Liability Company is **MEDINA'S ENTERPRISE, LLC.**

A member's interest in the Limited Liability company may not be sold or otherwise transferred except with unanimous written consent of all members.

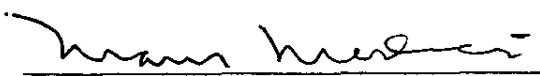
