ARTICLES OF ORGANIZATION of FIFTY TWO 2311, LLC

These Articles of Organization are adopted for the purpose of forming a limited liability company under the laws of the State of Florida, to be filed with the Florida Department of State, as follows:

ARTICLE ONE: NAME

The name of the company is Fifty Two 2311, LLC.

ARTICLE TWO: ADDRESS

The street address of the company is 411 63rd St NW, Bradenton, FL 34209 and its mailing address is the same. The company may subsequently change either such address as provided in the Operating Agreement of the company.

ARTICLE THREE: COMMENCEMENT AND DURATION
