

14.9 Applicable Law and Courts. This Agreement shall be governed by the internal laws of the State of Florida (without regard to conflict of laws or similar concepts). Jurisdiction and venue shall lie, and all legal proceedings shall be brought, in the Sixth Judicial Circuit in and for Pinellas County, Florida, or in the United States District Court for the Middle District of Florida.

With regard to any legal disputes arising out of or related to this Agreement, the prevailing party shall receive from the non-prevailing party(ies) all reasonable legal fees, costs, charges, and expenses incurred, including reasonable attorneys' fees, whether from the initial request for redress or through trial, appeal, and collection.

14.12 Successors and Assigns. This Agreement shall be binding upon the successors, assigns, heirs, and personal representatives of the parties hereto, including any person receiving any of the Units from a Member, but shall only inure to the benefit of successors, assigns, heirs and personal representatives who acquire the Units in a transaction permitted by this Agreement.
