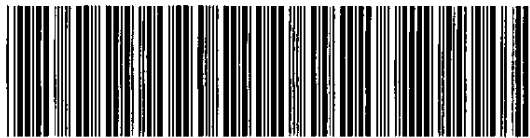




Continuation of Business


