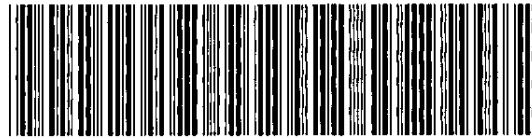

**ARTICLE 1
Name**

**ARTICLE 2
Purpose**

The purposes of this Company are to engage in any lawful activities which may be carried on by a limited liability company under the Act.

**ARTICLE 3
Principal Office**

**ARTICLE 4

Duration**

The death, resignation, removal, expulsion, retirement, bankruptcy, incompetency, dissolution, or termination of existence of a Member does not cause the dissolution of this Company, and the Company will continue the business of the Company notwithstanding the death, resignation, removal, expulsion, retirement, bankruptcy, incompetency, dissolution, or termination of existence of a Member. A Member does not have the right to withdraw or resign from the Company, to require the Company to redeem his interest in the Company, or to cause the dissolution of the Company.

ARTICLE 6 **Management**

This Company is to be a manager-managed limited liability company, managed by Managers.

ARTICLE 7 **Initial Registered Office and Agent**


