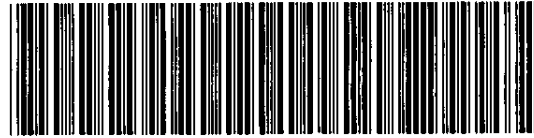

Name**
