# ARTICLES OF ORGANIZATION OF PINEAPPLE FISH, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

#### ARTICLE I - NAME

The name of the Company is PINEAPPLE FISH, LLC.

#### ARTICLE II - DURATION

The duration of the Company is perpetual.

#### ARTICLE III - ADDRESS AND PLACE OF BUSINESS

The street address of the principal place of the principal office of the Company in Florida is 525 Seagull Way, Anna Maria, FL 34216, and the mailing address of the principal place of the principal office of the Company in Florida is P.O. Box 841, Anna Maria, FL 34216.

#### ARTICLE IV - PURPOSE
