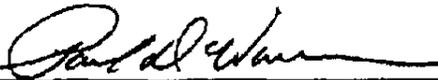

The Company shall be Manager-Managed. The Initial Manager of the company shall be Paul D. Warren.

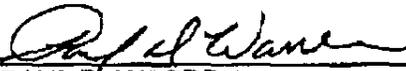
