ARTICLES OF ORGANIZATION
OF
CRJ MANAGEMENT LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes known and files the following Articles of Organization.

ARTICLE I -- NAME


ARTICLE V -- MANAGEMENT
