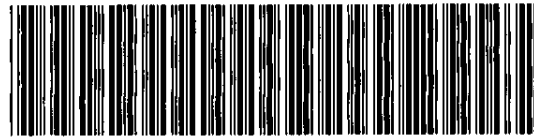

ARTICLES OF ORGANIZATION

FOR

BISHOP & COMPANY, P.L.

The undersigned organizer to these Articles of Organization hereby forms a professional limited liability company under the Florida Professional Service Corporation and Limited Liability Company Act.

ARTICLE V


Management
