

ARTICLES OF ORGANIZATION **OF**

MATHIS RACING, L.L.C. A LIMITED LIABILITY COMPANY

THE UNDERSIGNED, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - NAME

The name of the Limited Liability Company (hereinafter referred to as "Company") is MATHIS RACING, L.L.C.

ARTICLE II - PRINCIPAL OFFICE

The mailing address and street address of the principal office of the Limited Liability Company is 3331 Orlando Road, Panama City, Florida 32405.

ARTICLE III - REGISTERED AGENT, REGISTERED AND REGISTERED AGENT'S SIGNATURE

ARTICLE VII - REGULATIONS

Any regulations relative to this Limited Liability Company must be in writing and signed by all of the Members.

ARTICLE VIII - EVENTS OF DISSOLUTION

The Company shall be dissolved upon the happening of any of the following:

- 1. Upon written agreement of two-thirds of the membership.
- 2. Upon the death, retirement, resignation, expulsion or bankruptcy of a Member of any other event which terminates the continued membership of a Member in the Company, unless the remaining Members, within ninety (90) days after the event of occurrence, unanimously elect to continue the business of the Company pursuant to the terms of these regulations.
