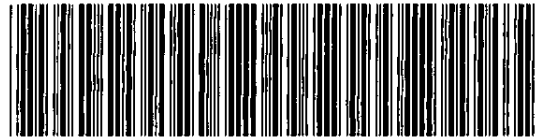

OF

The undersigned files these Articles of Organization in order to form a limited liability company pursuant to Florida Statute 608.407.
