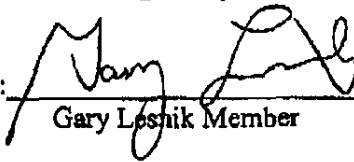

**ARTICLE VII - Existence of Company:**

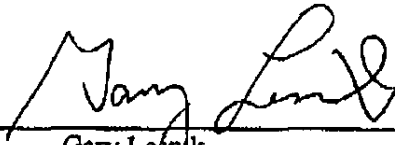
The existence of the Company shall commence on the date these Articles of Organization are filed with the Florida Department of State.
