

Articles of Organization Of North Lake County 4-Wheel Drive Club, LLC

Article I Name

The name of the limited liability company ("Company") is North Lake County 4-Wheel Drive Club, LLC.

Article VII Admission of New Members

Members of the Company have the right to admit new members. Members may admit to the Company additional members to participate in the profits, losses, available cash flow, and ownership of the assets of the Company on such terms as are determined by all of the members.
