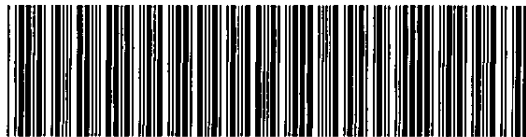


AMENDMENTS

The Articles of Organization of this Limited Liability Company may be amended from time to time as provided by law and the Operating Agreement of the Limited Liability Company.



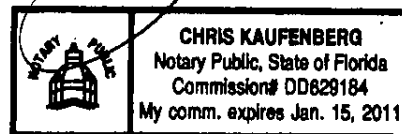
