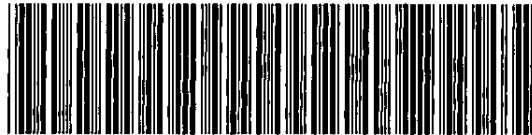



Both Managers shall hold office until the first annual meeting of the Company.

ARTICLE VIII

Deadlock Provision

Should the Managers be unable to make a decision regarding the activities and/or future of the Company, and should they be unable or unwilling to proceed forward, they shall agree to one of the following two options: 1.) The Company shall be dissolved and a proportionate division, in accordance with their respective ownership interests, of the Company assets and liabilities shall be rendered, or 2.) One Manager shall purchase the other Manager's interest in the Company for fair market value. With either option the two managers will pick a qualified corporate specialist whom is mutually agreed upon to render a fair market valuation of the Company. Both Managers will be bound by the

final determination of the fair market value of the Company by the mutually agreed to corporate specialist.


ARTICLE IX




