**ARTICLES OF ORGANIZATION  
OF  
RONI'S BRAS & MASTECTOMY BOUTIQUE, LLC  
A Florida Manager-Managed Limited Liability Company**

The undersigned Member does hereby execute these Articles of Organization for the purpose of organizing a Florida Limited Liability Company, pursuant to Chapter 608 of the Florida Statutes:

- 1 **Name.** The name of the Company is RONI'S BRAS & MASTECTOMY BOUTIQUE, LLC (the "Company").
- 2 **Mailing and Street Address; Principal Office.** The mailing and street address of the Company's principal place of business shall be 3280 N. Federal Highway, Boca Raton, FL 33431 but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.
3. **Duration** The Company shall exist from the date of filing these Articles with the Florida Department of State, or the later occurrence of any of the termination events specified in Florida Statue §608.441, or as may be provided in the Operating Agreement adopted by the Members, and its existence shall otherwise be perpetual.
4. **Registered Agent and Office.** The name and address of the registered agent of the Company is Joel T. Strawn, Esq., 54 N. E. Fourth Avenue, Delray Beach, Florida 33483.
5. **Management.** The Company shall be a manager-managed company, within the meaning of 608.402 (19), and initially shall be managed by the following person who shall serve as manager until the first annual meeting of the members or until his successor is elected and qualified. Manager: Roni Diener.
6. **Additional Members.** Additional members of the Company may be admitted as provided in the Operating Agreement.
7. **Termination of Membership** If a member of the Company dies, retires, resigns, is terminated, its entity is dissolved, experiences bankruptcy or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may continue the business of the Company.
8. **Indemnification.** To the maximum extent permitted by law, the Company shall indemnify any person who was or is a party to any proceeding by reason of the fact that the person is or was a manager, managing member or officer of the Company or is or was serving at the request of the Company as a manager, managing member, director or officer of another limited liability company, corporation, partnership, joint venture, trust or other enterprise against liability incurred in a manner that the person reasonably believed to be in, or not opposed to, the best interests of the Company and, with respect to any criminal action or proceeding, had no reasonable cause to believe his/her conduct was unlawful. The Company shall reimburse each person for all costs and expenses, including, without limitation, attorneys' fees, reasonably incurred by him/her in connection with any such liability in the manner provided for by law or in accordance with the regulations of the

Company. The rights accruing to any person under the foregoing provision shall not exclude any other right to which that person may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.

The undersigned, in accordance with Section 608.407(3), being one of the original members of the Company, hereby certifies that the foregoing constitutes the proposed Articles of Organization of RONI'S BRAS & MASTECTOMY BOUTIQUE, LLC.

In accordance with Section 608.408(3), Florida Statutes, the execution of this document constitutes an affirmation, under penalties of perjury, that the facts stated herein are true.


