ARTICLES OF ORGANIZATION

FOR

WARLICK DESIGN & CONSTRUCTION, L.L.C.

a Florida Limited Liability Company

ARTICLE I - Name

The name of the limited liability company is **WARLICK DESIGN & CONSTRUCTION, L.L.C.**

ARTICLE II - Address

The initial mailing address and street address of the principal office of the limited liability company is 667 Cherry Street, Winter Park, Florida 32789.

ARTICLE III - Duration

The Company shall be dissolved and its affairs wound up in accordance with the Florida Limited Liability Company Act (the "Act") and the Company's Operating Agreement on December 31, 2030, unless the term shall be extended by amendment to the Company's Operating Agreement and this Certificate, or unless the Company shall be sooner dissolved and its affairs wound up in accordance with the Act or the Company's Operating Agreement.

ARTICLE IV - Management

ARTICLE VII - Sharing of Profit and Loss

The profits and losses of the limited liability company shall be allocated among the members equally except as may be set forth in the regulation and/or a separate document signed by all members.


ARTICLE VIII - Admission of Additional Members

The remaining members of the limited liability company shall have the right to continue the business of the limited liability company on the death, bankruptcy or dissolution of a member or the occurrence of any other event as specified in the regulations of the limited liability company which results in the disassociation of a member from the limited liability company, upon the written consent of not less than fifty one percent (51%) of the Percentage Interests (as defined in the regulations of the Company) of such remaining members to continue the business of the limited liability company.
