### ARTICLES OF AMENDMENT To **Articles of Organization of**

# CALLAINSSEE, S. Make-A-Way, LLC (A Florida Not for Profit Limited Liability Company) Document # L08000044450

1. Pursuant to the provisions of section 608.411, Florida Statutes, the undersigned Florida limited corporation adopts the following articles of amendment to its articles of organization.

### MANNER OF ADOPTION:

There are no members or members entitled to vote on the amendment.

#### THE AMENDMENTS

The Articles of Organization of the Make-A-Way, LLC hereby amends the company articles of the organization in pursuant to include the following articles::

1. Article V of the Articles of Organization is hereby amended . The new Article IV reads as follows:

### Article V **Organization Purposes**

- The exclusive purpose of this limited liability company is to engage in housing and other social programs for the purpose of rental distributions to individuals who qualify according to Federal and State government requirements and partnership with other organizations that qualify as exempt under of section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.
- To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purpose, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.
- 2. The following additional Article is hereby added to the Articles of Limited Liability Company. Article VI reads as follows:

Article VI 501(c)(3) Limitations

- A. ORGANIZATION PURPOSES: Notwithstanding any other provision of these articles, this organization shall not carry on activities that are not permitted to be carried on by an organization exempt from Federal and state income tax under section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code...
- B. NO PRIVATE INUREMENT: The company is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The company shall not distribute any gains, profits or dividends to the Directors, Officers, or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out the company's charitable and educational purposes. The property, assets, profits and net income of the company are irrevocably dedicated to charitable and educational purposes no part of which shall inure to the benefit of any individual.
- C. LOBBYING AND POLITICAL CAMPAIGNS: No substantial part of the activities of the company shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the company shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
- D. DISSOLUTION: Upon winding up and dissolution of the company, the assets of the company remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes. If the company holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the company's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.
