ARTICLES OF ORGANIZATION OF SUNG TAE KIM LAWN CARE, L.L.C.

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

ARTICLE I Name

The name of the limited liability company shall be SUNG TAE KIM LAWN CARE, L.L.C.

ARTICLE II Address and Place of Business

The mailing address and principal place of business for the limited liability compared

ARTICLE III Period of Duration
