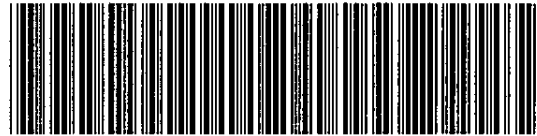

All the remaining property and assets of the Company, have been distributed to its members.




