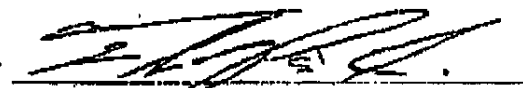
#### ARTICLE VI. PURPOSE

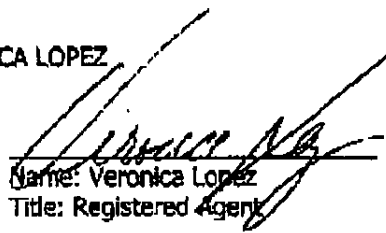
