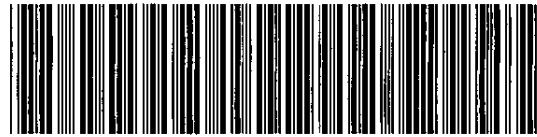

The name of the Limited Liability Company (hereinafter referred to as "Company") is **PREFERRED REAL ESTATE PROPERTIES, L.L.C.**

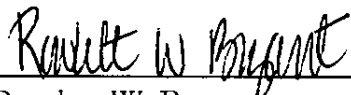
**ARTICLE II - PRINCIPAL OFFICE**
