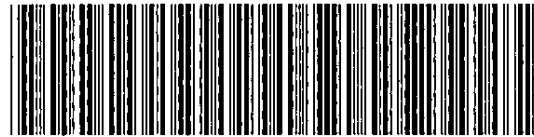

ARTICLE 1 - NAME

The name of the limited liability company shall be **A BETTER ALTERNATIVE MAGAZINE LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 2808 Prince John Road, Winter Park, Florida 32792 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

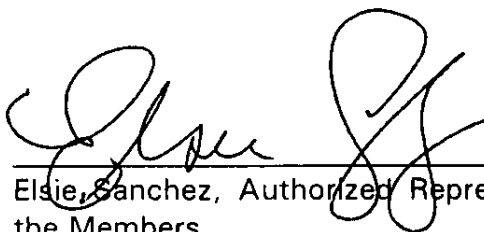

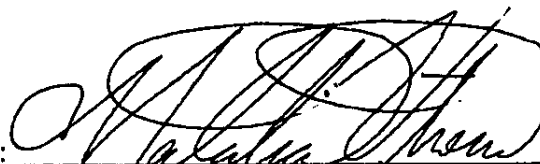
