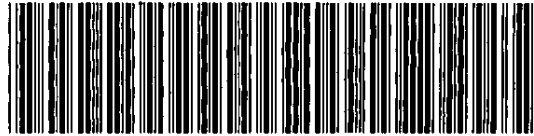

The mailing address and street address of the principal office of the limited liability company is 485 Harbor Drive South, Indian Rocks Beach, FL 33785.

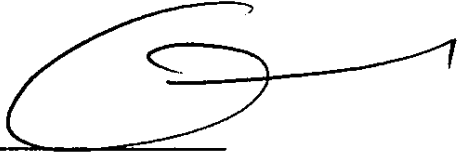
ARTICLE III - Registered Agent & Office:

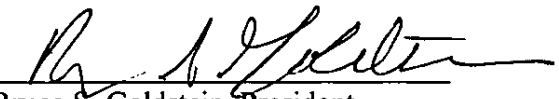
