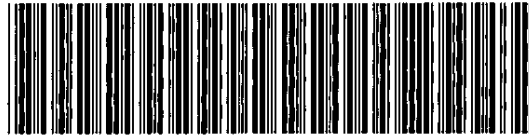

**ARTICLES OF ORGANIZATION
OF
ALTERNATIVE ENERGY SERVICES OF North Florida, LLC**

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be Alternative Energy Services of North Florida, LLC ("Company"), the principal place of business of the Company in Florida shall be 6712 Visalia Place, Tallahassee, Florida 32317. *MAILING ADDRESS IS SAME AS PRINCIPAL.*

**ARTICLE II
DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The existence of the Company shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE III
PURPOSES, OBJECTS AND POWERS**

- A. Purposes: The Company is organized and shall be operated for the following purposes:
1. To engage in the business of solar, wind and hydroelectric alternative energy services.
- B. Powers: The powers of this Company are:
1. This Company shall have all the powers now or hereafter conferred by Florida law upon limited liability corporations, as described in Section 608.404 F.S.

MEMBERS AND CAPITAL CONTRIBUTIONS**

**ARTICLE VI
ADMISSION OF NEW MEMBERS (TRANSFERABILITY OF INTERESTS)**

No additional members shall be admitted to the Company except with the unanimous consent of all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company, other than the member proposing to dispose of his or her interest, approve of the proposed transfer by unanimous consent.

In the event of death of a member, the Company shall have the right but not the obligation to purchase the interest of the deceased member. The purchase price shall be determined by an independent appraisal and shall be paid as mutually agreed upon. If the company determines not to purchase the interest of the deceased member, the beneficiaries shall be entitled to all benefits inuring to the other members but shall have no right to participate in the management and affairs of the company.


