3. The Articles are hereby further amended by striking Article II thereof in its entirety and by substituting in lieu of said Article II the following new Article II:

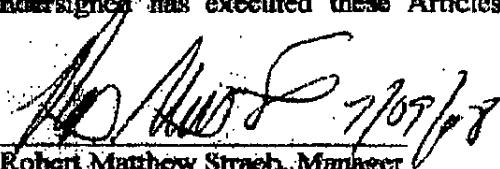
