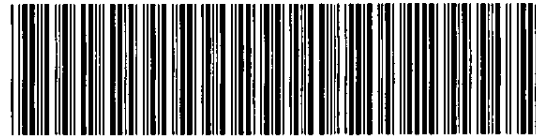

ARTICLES OF ORGANIZATION
OF

(a Florida Limited Liability Company)

The undersigned certifies that I have organized for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit.

ARTICLE I
(Name and Principal Place of Business)


