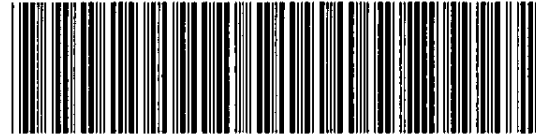

The initial principal office of the company shall be located at, and the mailing address of the company shall be 3232 Quiet Water Lane, Gulf Breeze, Florida 32563.

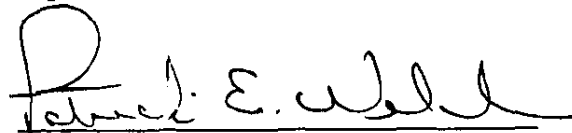

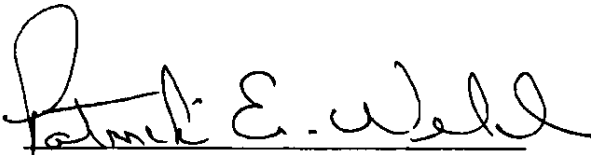
