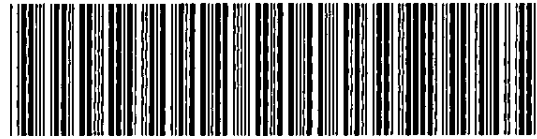

1. Name. The name of this limited liability company is **THE MAJORS GOLF CLUB, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist effective as of May 9, 2008 and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

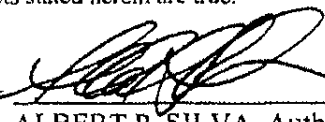
6. Management of the Company. The management of the Company shall be vested in the Board of Managers of the Company. The name and address of each Manager on the Board of Managers are as follows:

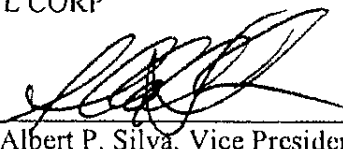
