

## ARTICLES OF ORGANIZATION

## **ARTICLE 5 - PURPOSES AND POWERS**

The general purpose for which the Company is organized is to engage in the business of medical business investments and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida.
