ARTICLES OF ORGANIZATION OF NOCHAWAY MITIGATION PRESERVE, LLC

The undersigned individual hereby adopts these Articles of Organization in order to form a limited liability company under Chapters 608, Florida Statutes.

ARTICLE I

The name of the limited liability company is Nochaway Mitigation Preserve, LLC (the "Company").
