ARTICLES OF ORGANIZATION

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.


ARTICLE 4 - DURATION

<u>ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT</u>


