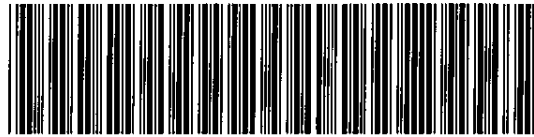

ARTICLE I. Name. The name of the limited liability company is VJM CONSULTING, LLC.

ARTICLE VII. Period of Duration. The period of duration shall be perpetual.


