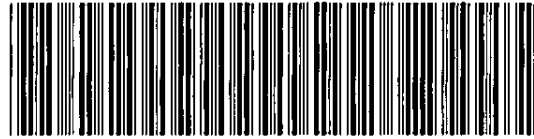

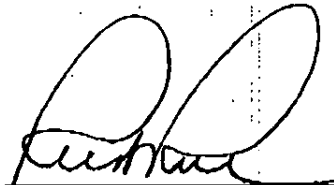

#### **ARTICLE V- BUSINESS PURPOSE**

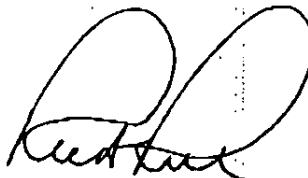
The primary business purpose of this Company is investment in closely-held business entities, in addition to any other purposes permitted under Florida law.
